

CGU - AMInstitute Awards Program

Recognising the excellence of young professionals within the mutuals industry

AMInstitute is committed to the education and professional development of young professionals working within the mutual sector and is pleased to continue its support of the Awards Program, proudly sponsored by CGU. Originally launched as the Membersafe Young Achievers' Award, it was initiated in NSW in 2002 and is now in its eighth year as a national award. It provides up to five young credit union and building society employees with the opportunity to attend the AMInstitute Leadership Forum in Yarra Valley Victoria, 11-13 March 2011 incorporating a special Emerging Leaders Program on day one. The award will be for one Young Achiever from each of the following regions – WA/SA/NT, QLD, NSW/ACT and VIC/TAS.

An additional prize in the form of a Scholarship Award will be awarded to the entry judged as the most outstanding from those meeting the specific entry criteria and will provide funding for a Graduate Certificate in Management through a strategic partnership between AMInstitute and the University of South Australia (UniSA).

AMInstitute has entered into a partnership to jointly deliver an MBA program with UniSA to eligible managers and supervisors who are employed in Credit Unions / mutual Building Societies.

The MBA consists of 12 courses, and is structured in 3 stages. The first stage comprising 4 courses make up the Graduate Certificate in Management. Building on those 4 courses, by successfully completing another 4 courses the participant achieves the Graduate Diploma in Management and by successfully undertaking a further 4 courses the participant will be awarded an MBA. Each course is undertaken during an 11 week term, and the MBA is scheduled for 3 to 4 courses each year. You can study from wherever you are working or living, as the program is undertaken entirely online - anywhere, any time, any place.

This Scholarship Award will pay the fees of the first 4 core courses – the first stage - of the MBA.

* Alternatively, for anyone who is currently undertaking a similar type of course at this level, like a graduate certificate, graduate diploma or recognised degree from an accredited educational institution, **(or may have recently enrolled in a course which will commence in 2011)** will have their course fees paid (up to the value of \$9,000). This was a new initiative that has provided even greater value and flexibility since its introduction in 2008.

We look forward to support and participation from your credit union or mutual building society.

Judging Criteria

Nominations in the form of a written submission, are to address the following key judging criteria:

CGU - AMInstitute

1. Young Achievers' Award*

Nominees are requested to demonstrate to the judges:

- Why they are considered to be a "young achiever" in their credit union / building society.
- What do they believe leadership means and/or what skills do they believe a successful leader should have.
- What they have to offer the credit union / mutual building society industry.

2. Scholarship Award*

As a minimum, nominees for this award are expected to hold a managerial, supervisory, or team leader role within their credit union / building society, and to meet the University's admission criteria. They are requested to demonstrate to the judges:

- How education has influenced and assisted their career to date.
- Why they believe the Scholarship Award will make a difference to them personally and add value to their contribution within their mutual ADI.
- How, by completing a Graduate Certificate in Management (as part of the UniSA MBA Program); or their current course; or undertaking studies in the future is their own career likely to benefit and be advanced.

** Please note: Clearly indicate the award you are nominating for by ticking the appropriate box on the nomination form. If you are nominating for the Scholarship Award, you are also encouraged to nominate for and complete the section for the Young Achievers' Award.*

In choosing to enter the Award competition, nominees have 3 options:

Nomination Submissions



1. They may submit an entry for one of the four Young Achievers' Award prizes; or
2. Submit an entry for the Scholarship Award (subject to meeting the University's entry criteria* - where applicable); or
3. Submit their entry for both the Young Achievers' Award prize and the Scholarship Award.



Nomination Forms are now available and nominations will be accepted until 26th November 2010. The four regional winners will be announced via an AMInstitute bulletin during the week commencing 13 December 2010. The winner of the Scholarship Award will be announced at the Awards Program presentation during the 2011 AMInstitute Strategic Leadership Forum. Nominations can be hand delivered or posted in an envelope marked:

Subject to meeting the necessary criteria, a nominee who wins a Young Achievers' Award may also be eligible to win the Scholarship Award. Both prizes will be judged separately.

*In the case of UniSA, an undergraduate degree and at least 2 years relevant work experience OR at least 6 years in a middle management supervisory/team leader role – the titles may vary depending on the organisation.

The judge's decision is final. To be eligible for entry for this awards program, nominees must be under the age of 35 at the time of the nomination and employed in a professional capacity by an Australian credit union or mutual building society. Winners will be disqualified if they are not employed by an Australian mutual ADI when the awards are announced and redeemed. In the event that any winner is ineligible the judges will award the prize to the next eligible runner up. Eligible winners must be based in the region for which the award is given.

All information provided by the nominee or their nominator/sponsor must be true and accurate and the judging panel reserves the right to seek confirmation of any detail or claim made. If the nominee does not meet all the eligibility criteria, they will be unable to enter the awards.

Upon the advice of the University of South Australia, AMInstitute and CGU reserve the right to suspend the continued payment of the scholarship for any person that fails to achieve a standard deemed acceptable by the University; fails one or more units; or, is considered unlikely to complete their studies to at least the minimum standard required to be awarded the Graduate Certificate of Management.
