Guest Speaker: Oliver Hudson, Head of Financial Markets & Treasury, Cuscal

The "Credit Crunch" and Mutuals

Oliver holds over a decade of industry expertise. Starting at Cuscal in 2001 in the Market Risk area, he headed the restructure of the businesses Treasury environment, balancing the high liquidity and risk aversion needs of Cuscal's customers. Shortly after, Oliver was assigned the responsibility of the Financial Markets and Treasury functions, including the management and funding of Cuscal's Securitisation Trusts to increase returns within a very conservative risk environment.

Oliver's understanding of financial risk and balance sheet management in highly volatile markets comes from his employment at WestMerchant Bank and Credit Suisse First Boston in London, prior to joining Cuscal. Originally working in Emerging Markets Fixed Income through the Russian Default Crisis and the contagion effect to Brazil and Argentina; and then subsequently in European Equities markets through the peak of the Dotcom IPO boom. Oliver holds a bachelor of commerce in Finance & Economics and a Masters of Applied Finance. Oliver is Cuscal's Responsible Officer representative to ASIC for all Balance Sheet and Trust business.
